STUDENT TRANSFER FORM

As a transfer student (i.e. you transfer from one Dutch higher education institution to another) you're already in possession of a Dutch Residence Permit for study purposes (study permit). As soon as you transfer to another institution the Dutch Immigration and Naturalisation Service (IND) needs to be informed about that, and the new institution (in this case HAN) needs to become your new sponsor for the IND. To determine whether you meet all the requirements for holding a study permit you need to provide HAN with the requested information and documents as outlined below.

Conditions

HAN University of Applied Sciences will consider your request for the IND sponsorship separately from your request for admission to HAN. This means that even though you may have been accepted for a study program at HAN, your request for the sponsorship may be denied if you do not meet the requirements for holding a residence permit for study purposes.

- a copy of your valid **healthcare insurance** that covers you for this calendar year
- proof of **sufficient financial means to provide for your day-to-day living expenses**. Please hand in your bank statement. In case you have a sponsor, hand in the sponsor (abroad) letter + a copy of your sponsor's passport/ID card + a copy of your sponsor's bank statement.
